

POSITION DESCRIPTIONS

General Information

There are 6 officer positions: president, president-elect, vice president of professional development, vice president of outreach, secretary, and treasurer.

Eligibility & Office Terms

- The president, president-elect, and vice president(s) must have current SWE membership.
- All other section officers must be voting members of the section.
- Section officers shall serve for a term of one fiscal year, to coincide with the Society's fiscal year.
- Officers may hold more than one office provided that there is a minimum of three elected officers of the section.
- No one may hold the office of president and treasurer at the same time.

President

- 1. Represent the section before the public and preside at meetings of the section and its executive council
- 2. Appoint the chairs of all committees, with the approval of the executive council, except the chair of the nominating committee
- 3. Approve the appointment of all committee members, except the members of the executive council
- 4. Authorize the disbursement of the section funds within the budget approved by the executive council
- 5. Be an authorized signatory on all section accounts
- 6. Coordinate activities and execute the business and policies of the section between meetings
- 7. Review and approve the year-end section financial report
- 8. Perform other duties normally associated with the office of the president or as may be assigned by the executive council or the governance documents

President-Elect

- 1. Serve as president in the year following their term as president-elect
- 2. Assume the duties of the president if the president is temporarily unable to serve
- 3. Assist the current president with all duties

VP Professional Development

- 1. Assume the duties of the president if the president is temporarily unable to serve and if president-elect position is unfilled or if president-elect is also temporarily unable to serve
- 2. Chair the professional development committee
- 3. Coordinate activities of other committees that pertain to professional development of section members
- 4. Perform such other duties as may be assigned by the president, the executive council, or the governance documents

POSITION DESCRIPTIONS (CONT)

VP Outreach

- 1. Chair the career guidance committee
- 2. Coordinate activities of other committees that support the section's career guidance goals
- 3. Perform such other duties as may be assigned by the president, the executive council, or the governance documents

Treasurer

- 1. Be responsible for the collection, distribution, and safekeeping of sections funds
- 2. Prepare, maintain, and report as directed on the financial position of section in relation to the approved budget
- 3. Submit a financial report to the Society in accordance with established procedures
- 4. Perform other duties normally associated with the office of treasurer or as may be assigned by the president, the executive council, or the governance documents

Secretary

- 1. Maintain the records of the section
- 2. Perform other duties normally associated with the office of secretary or as may be assigned by the president, the executive council, or the governance documents

Biography
